

# MEMORANDUM OF UNDERSTANDING

Memorandum of understanding between the JHARKHAND ARCHERY ASSOCIATION (hereinafter known as JAA) & RANCHI UNIVERSITY (hereinafter known as RU)

## PREAMBLE

The Jharkhand Archery Association an affiliated unit of Archery Association of India & Jharkhand Olympic Association and Ranchi University hereinafter called the Partners." found it mutually beneficial to have a formal understanding between the two Partners in taking up collaborative sports programmes for Archery Sports at Ranchi University Campus, Saheed Chowk, Ranchi. Both the parties will make use of its own resources along with strength and experiences of JAA to contribute to the ongoing process of developmental programme for Archery to achieve sustained development and progress in the sports of Archery for the State Players and the players of the Ranchi University.

### **1. THE PARTNERS**

The partners of this Memorandum of Understanding are the JHARKHAND ARCHERY ASSOCIATION & RANCHI UNIVERSITY represented by the General Secretary and or his nominee on one side and the vice-Chancellor or his nominee represented on the other side

### **2. DETAILS OF UNDERSTANDING**

The partners, after due consideration of various aspects have arrived at the following understanding in respect of the Sports projects mentioned in the earlier paragraphs

- # The Jharkhand Archery Association will provide free of cost, training to the Archery players of Ranchi University which may include deployment of trained Coach time to time.
- # The Jharkhand Archery Association will also provide necessary technical assistance to Ranchi University in organizing different level of Training/Competition/Selection/Tournaments without any financial liability, whenever required.
- # The R U will provide space for the Archery training Center at Ranchi University campus and Jharkhand Archery Association will use the same only for conduct of Archery Regular Training, Camp, Seminar and Workshop etc.
- # The intention to use the Ranchi University Archery Coaching Centre in R U Campus, Saheed Chowk, Ranchi provided by RU is for Archery only. For any other project has to be notified in advance and written permission of RU has to be obtained in consultation with JAA
- # The maintenance of the play ground will be the responsibility of JAA. However the maintenance of other areas shall rest with R u.
- # RU shall arrange equipments as and when required for its players.
