

MEMORANDUM OF UNDERSTANDING

Memorandum of understanding between the JHARKHAND VOLLEYBALL ASSOCIATION & RANCHI UNIVERSITY

Preamble

The Jharkhand Volleyball Association an affiliated unit of Volleyball Federation of India & Jharkhand Olympic Association and Ranchi University hereinafter called the "Partners", found it mutually beneficial to have a formal understanding between the two Partners in taking up collaborative sports programmes for Volleyball at Ranchi University Volleyball Coaching Centre in RU Campus, Saheed Chock, Ranchi. Both the parties will make use of its own resources alongwith strength and experiences of JVA to contribute to the ongoing process of developmental programme for Volleyball to achieve sustained development and progress in the sports of Volleyball for the State Players and the players of Ranchi University.

1. The Partners

The Partners of this Memorandum of Understanding are the JHARKHAND VOLLEYBALL ASSOCIATION & RANCHI UNIVERSITY

Represented by the General Secretary and or his nominee on one side and the Vice-Chancellor or his nominee represented by the on the other side.

2. Details of Understanding

The Partners, after due consideration of various aspects have arrived at the following understanding in respect of the sports projects mentioned in the earlier paragraphs.

- * JVA will provide free of cost, training to the Volleyball players of Ranchi University which may include deployment of trained Coach time to time.
- * The JVA will also provide necessary technical assistance to Ranchi University in organizing any level of Training/ Competition/Selection/Tournaments without any financial liability, whenever required.

Volleyball Practice Camps/Tournaments etc listed in this MOU. The intention to use the Ranchi University Volleyball Coaching Centre in R.U. Campus, Saheed Chowk, Ranchi provided by RU for any other project has to be notified in advance and written permission of RU has to be obtained in consultation with JVA.

3. The maintenance of the play ground will be the responsibility of JVA, however the maintenance of other areas shall rest with RU.

- * RU shall arrange at least 50 Volleyballs and Nets as required for its players.
- * JVA shall assist the RU in selection/training; however it shall not take the responsibility of the selection criteria for team of RU.
- * The maintenance shall include the constructed area of the campus other than play Ground,
- * The J.V.A. will utilize the office room of R. K. Anand Media Gallery for office purpose.

4. Date of Effect


